GENERAL AGREEMENT

BETWEEN

UNIVERSITY OF TEACHER EDUCATION ZUG

AND

UNIVERSITY "KADRI ZEKA" GJILAN

Preamble

The Rector of the "University of Teacher Education Zug" hereinafter PH Zug and the Rector of the University "Kadri Zeka" in Gjilan, hereinafter UKZ willing to reinforce their academic relationship and to continue the active cooperation, agreed in the following issues:

Article 1: Objectives

Both parties agree to promote co-operation between "University of Teacher Education Zug" and the University "Kadri Zeka" in Gjilan, within framework laid out hereinafter. In particular, this cooperation shall extend to all areas of scientific and educational programs as agents of development. Both parties agree to act accordingly to positive regulations.

Article 2: Contents

Both institutions agree to contribute to this Agreement based on their mutual interests and initiatives, within the framework of the regulations applying in each of the institutions, subject to availability of resources, the following:

1. Organizing joint research activities, including for this purpose, the exchange of faculty members and research personnel,
2. Activities involving students and staff.
3. Exchange of initiatives, information and experiences in scientific research and education as well as academic and other publications;
4. Organizing joint international conferences, seminars and academic meetings

For the purpose of the implementation of the abovementioned activities will be prepared an action plan, or a concrete project or program.

Article 3: Cooperation Support

Both parties agree, in order to pursue realization of the proposed activities in **Article 2** of this Agreement, to support other forms of cooperation with the governmental, academic, economic and other institutions and make effort towards their realization and development.

Article 4: Financial Issues

Both parties agree that organizational, financial and other issues related to the form of cooperation performed under this Agreement on either side shall be arranged to specific contracts for each particular activity or programme.

Article 5: Representatives of the parties

Each institution will elect its own representative for general purposes. The two representatives have to decide on the activities.

Article 6: Planning Instruments

A 5-years roadmap will be drafted to be used as a guideline for the partnership.

Article 7: Entry into effect

The Agreement shall be forwarded to each institution's Government Bodies and signed by their principals. The Agreement shall come into effect once signed by the parties.

Article 8: Agreement Duration and Termination

This Agreement shall enter into force as of the date on which last party has signed it and will replace the current general agreement. The Agreement remains in force for five years. Any amendment of and/or modification to the Agreement will require written approval from the Heads of both institutions. Before expiration, this Agreement may be renewed by mutual consent.

Either party can terminate this Agreement by providing the other party with written notice at last six (6) months prior to the suggested date of termination.

This Agreement can be terminated at any time, if mutually agrees upon. This termination shall not affect the exchanges, projects or activities in progress unless otherwise agreed by both parties.

Article 9: Amendment

Any modification to the agreement is going to be made upon consent of both institutions, and it must follow a procedure identical to that the original agreement.

Article 10: Language and copies

This Agreement is drawn in two (2) identical and equally valid copies in English. Each of the involved parties shall retain one (1) copy.


