### Abstract guidelines for authors

Submitted abstracts have to be written according to the following instructions:

- Abstracts should be written in English.

- Abstracts must be typed in a Microsoft Word for Windows format, using Times New Roman font in 12-point, regular style, single-spaced, with justified alignment and 2.5 cm margins on all sides.

- Abstractsshouldcontainapproximately400 words.

- The abstract should indicate the purpose of the research and how it relates to the Conference topic, the approach used, the significant results, and the implications.

#### Abstracts Critical Requirements:

- **Title**: The abstract title should be 12-point Times New Roman and bold.
- **Author name**: full name of the writer(s), institution/affiliation and email address.
- **Body**: The abstract should be 10-12 points, not bold, single-spaced Times New Roman, and up to 400 words long. The abstract should be fully justified.
- Keywords: Keywords should be italicised in Times New Roman, 10 points.
